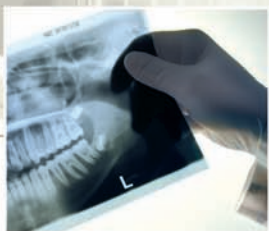

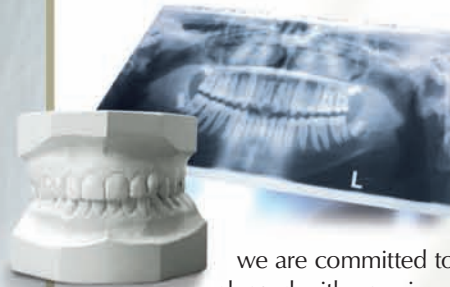

How do I get started?

Just call and schedule an appointment at your most convenient location. The initial visit averages approximately 30 minutes. During your first visit, we will perform an oral exam and discuss our findings regarding your, or your child's, orthodontic needs.

If treatment is necessary, we will recommend the appropriate records be taken to prepare a complete diagnosis.

How do I pay for the care?

There is no charge for your initial exam. Should orthodontic treatment be recommended and diagnostic records be taken for study, a nominal records fee will be charged.



After we have diagnosed and discussed the treatment and you are ready to proceed, the office manager will review the cost and various payment options.

Will insurance cover the care?

Should you have any questions concerning your insurance, our staff will be happy to assist you. Be sure to bring your insurance forms with you. We will file



your claims as a courtesy service. Due to variations of individual insurance policies, we suggest that you contact your insurance company or employer directly for more detailed information.

Are there any forms I need to complete for the care?

You will receive a patient history form in your introductory packet. This should be completed with the patient's information and returned to our office on the day of the first appointment.

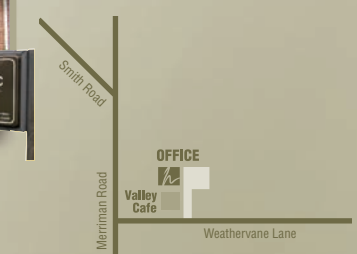
